

ISLAND BOAT SHOW EXHIBIT TERMS, RULES AND REGULATIONS

1) PAYMENT FOR SPACE

- a) Payment requires 25% down on November 1, 2018 and final payment by December 15, 2018
- b) Space agreement and payment, if not executed in person with a boat show representative is to be mailed to:

2) CANCELLATIONS AND SPACE CHANGES

- a) If an exhibitor wishes to cancel this agreement, he must contact a boat show representative and the cancellation must be confirmed in writing by a boat show representative. A monetary penalty may be applied.
- b) Space changes are subject to approval by a boat show representative.

3) SUBLEASING

- a) Exhibitors may not sublease any portion of their purchased space.

4) LIABILITY, RELEASE, WAIVER AND INDEMNIFICATION

- a) Exhibitor releases Island Christian School, Island Community Church, Inc., their officers, directors, employees, agents, and volunteers from any claim, liability, losses, costs or expenses relating to or arising out of any injury to any personnel of exhibitor, or to any other persons or any damage to any property of exhibitor. The Exhibitor shall be responsible for such injury, loss or damage and any expenses relating thereto.
- b) Exhibitor shall indemnify, hold harmless, defend and reimburse Island Community Church, Inc., Island Christian School, and their managers, contractors, directors, officers, employees, agents and volunteers from any and all actions, claims, demands, liabilities, losses, attorney fees, cost of litigation which indemnities for any reason resulting from, relating to or arising out of Exhibitors participation in the Island Boat Show; including but not limited to the negligence, gross negligence, criminal acts and any injury to or death of any persons or any loss through theft or otherwise damage to property.
- c) This agreement shall be governed by and construed in accordance with the substantive law of the **State of Florida**.

5) INSURANCE – Exhibitor is required to provide and keep in force during the show period, including move in and move out periods the following insurance:

- a) Workers Compensation and Employers Liability Insurance (Certificate of Insurance Required).
- b) Commercial General Liability (or its equivalent) including products, completed operations, personal and advanced liability with a per occurrence limit of not less than \$1,000,000.
- c) Automobile Liability Insurance with a limit of \$1,000,000 per occurrence.
- d) Protection and Indemnity (P&I) Insurance is required on any boat in the amount not less than \$1,000,000 as respects to boats used for demonstration rides.
- e) Additional Named Insured Endorsement must include Island Community Church, Inc. and Island Christian School on both Commercial General Liability and Automobile Liability policies. Certificate must be delivered before December 01,2018 to a boat show representative or mailed to Island Christian School at above address under 1b.
